Prescot Business Club – Town Clerk

The Town Clerk has attended two business club meetings since the annual meeting in May.

The first of these was a Business Club – Events Committee Meeting which was attended by one of KMBC's Town Centre Managers (Mark Bingley) were Christmas Lights was discussed. KMBC have now reinstated a budget for Town Centre Christmas Lights and therefore would like to pool its resources with the Town Council to enhance the Light provision throughout the Town and the switch on. The combination of these budgets can only be a good thing for the Town and as such the Town Centre Manager will need to be invited to the next Town Council events committee meeting.

The Second meeting was held on Tuesday evening and was the full Business Club Meeting. The Chair (Louise Gillespie) had invited John Flaherty KMBC's Executive Director for Communities and Neighbourhoods. John is also the lead officer for the regeneration of Prescot, as such John was able to provide an update with regard to

- Shakespeare North, final build costs are due to be received very soon and the
 project has an estimated completion time of roughly two years. Enabling
 works are proceeding according to plan.
- Market Place, the works to develop the public realm at Market Place are progressing and are due to be completed by September.
- The Shopping Centre the centre is owned by Geraud Markets, John had recently met with one of the owners of the company and had candid conversation about the future of the site and lack of investment on the part of Geraud. John had informed Geraud that KMBC would be willing to purchase the site and left the company to ponder the decision.

Prescot in Bloom, this was another point raised, for some time there has been discussion about installing hanging baskets outside each of the shops in the town centre. Unfortunately, the uptake has been very slow, in order to try and increase this the Town Clerk has offered to personally put up any hanging baskets that shop owners are struggling to have installed.

A second point was raised about the entry points into the town and how it would be beneficial to enhance them with signage and floral displays. To that end I have contacted Mr Flaherty to enquire about the possibility of reinstating the flower beds along Derby Street opposite the old Police Station, should I get a positive response, I will prepare a report for consideration at Finance, General Purpose and Human Resources Committee.
