66. PRESCOT CARNIVAL FEEDBACK REPORT

It was **UNANIMOUSLY RESOLVED** to **APPROVE** the recommendations at 2.5 being:

- 2.5.1. Members should offer any other points on lessons learned for consideration at the meeting.
- 2.5.2. The success of the carnival in attracting visitors and the setup, in its current format strongly suggests we should retain this method of organisation and delivery.
- 2.5.3. The success of the carnival in attracting visitors in June strongly suggests the carnival should run around the same time next year during the Prescot Festival of Music and Arts on either Sunday 21st June 2020 (Father's Day) or Sunday 28th June 2020 and members should agree a date to enable early planning of the event as this is the most fundamental decision taken in relation to the event. The date agreed is 28th June 2020.
- 2.5.4. Following the success of the West Lancs Dog Display team this year drawing in the crowds along with getting members of the audience involved in the show it is recommended that Members agree to hire them again for next year's Carnival to ensure their availability, they have confirmed the fee for next year will remain at this year's price of £500.
